JUDGING REQUIREMENTS:

- Participation is open to any photographer-professional, amateur, student or other
- **PHOTOGRAPHS CAN PORTRAY ANY ERA OR ASPECT OF DETROIT, IN A POSITIVE LIGHT**
- Photographs may be color, black and white, color tinted, traditionally and/or digitally processed
- Submit only Jpeg files
- 200 DPI
- 10 MB maximum file size
- No bigger than 10 in.
- You may submit images of up to 5 photos
- Images for judging must be submitted on line to faye@artsleague.com or you can drop off a CD.



PHOTOGRAPHS ACCEPTED FOR THE EXHIBITION:

- The original(s) must be delivered to the Carr Center by 5 p.m., Friday, July 30th. They must be professionally mounted or framed, wired for hanging, and be in a removable protective cover.
- Maximum mounted/framed size is 3' X 3'. Maximum weight is 15 pounds.
- Each piece must be accompanied by a **PRINTED** statement (max. 200 words) about the photo.
- Each photograph must have the ***ALM I.D. LABEL** below, securely attached to the back of the piece. Please cut and use this label only. **ALL INFORMATION MUST BE PRINTED.**

ENTRY FEE:

- Students - **\$10** / Arts League Members - **\$15** / Non-Arts League Members - **\$25**

SALE OF PHOTOGRAPHS:

- All entries must be for sale. The ALM applies the standard Gallery commission of 40% to all sales.
- The ALM will collect a non-refundable deposit from potential buyers. The final payment will be due September 20, 2010.

The ALM will insure all exhibition pieces against loss or damage from 9:00 a.m., Friday, July 30, 2010 through 5:00 p.m., Monday, September 20, 2010. The ALM is not responsible for photographs that are not picked up by the end of the insured period unless other arrangements have been agreed upon with the ALM, in writing. Should your work(s) be damaged during the insured period, you will be reimbursed the price of repair. If a piece is destroyed, lost or stolen, you will be paid 60% of the price of the art piece. The ALM 40% gallery fee applies.

The buyer of your photo(s) can take possession of the piece on September 20, if full payment has been received. You will be paid 60% of your sale price within 30 days. If the buyer does not make the final payment by September 20, the sale will be cancelled and you will be paid 60% of the non-refundable deposit within 30 days.

By signing this Exhibition Contract, you declare that you are the legal owner of all rights to the photographs listed and agree to all the contract terms and requirements. You also agree to grant the ALM permission to reproduce your photo(s) accepted for exhibition, and your image for ALM publicity and educational purposes.

Note: The ALM curator reserves the right to deny the acceptance of if any photographs deemed unsuitable for display or too difficult to install.
